### **DID YOU KNOW?**

#### ADA COMPLIANCE: LOCAL GOVERNMENT WEB & SOCIAL

Increasingly, citizens access local government services through the Internet and mobile devices. For many, critical actions like voting and paying taxes involve finding what is needed online. The Department of Justice (DOJ) has ruled that this "virtual front door" to a City or Village Hall must comply with Americans with Disabilities (ADA) standards.

In April, the DOJ released its final rule updating regulations for Title II of ADA. This final rule establishes that local government's web and mobile applications must comply with the Web Content Accessibility Guidelines (WCAG) Version 2.1, Level AA as a technical standard.

Municipalities with a population of 50,000+ have until April 24th, 2026 to comply.

Municipalities with a population between 0 to 49,999 have until April 26th, 2027 to comply.
